Activity Requirements

Students

Schools must consider age, maturity and skill level of students when planning curriculum activities. Adjustments are required for students with disability to support access and participation in the curriculum. Consult with the parents/carers of students with disability, or when appropriate the student, to ensure risks related to their child's participation in the activity are identified and managed.

Schools must consult current student medical information and/or health plans in accordance with the ? Managing students' health support needs at school procedure. Record information about any student condition (e.g. physical or medical) that may inhibit safe engagement in the activity and include specific support measures within emergency procedures.

The school's sun safety strategy must be followed if participating outside.

Follow the Managing excessive heat in schools guidelines on hot days.

Emergency and first-aid

Emergency plans and injury management procedures must be established for foreseeable incidents (e.g. separation from group, fire/evacuation).

Adult supervisors must have:

- emergency contact details of all participants
- a medical alert list and a process for administering student medication;
- communication equipment suitable to conditions (e.g. mobile phone) and a process for obtaining external assistance and/or receiving emergency advice;
- an appointed emergency contact (e.g. the Principal).

Safety procedures must be determined for the location (e.g. roll marking, process to rapidly communicate emergency advice to adult supervisors of impending severe events) and are to be informed by available safety information (e.g. venue/expert advice, manufacturer's instructions, product labels, vendor SDS and SOP).

Access is required to First aid equipment and consumables suitable for foreseeable incidents.

For participants with known allergies, schools must comply with the <u>Supporting students with asthma and/or</u> at risk of anaphylaxis at school procedure and the school's Anaphylaxis Risk Management Plan, including an adult supervisor of the activity with anaphylaxis training.

An adult with current emergency qualifications for foreseeable incidents is required to be quickly accessible to the activity area.

Induction and instruction

Induction is required for all adult supervisors on emergency procedures, safety procedures and correct techniques. If the activity is conducted at an off-site facility, induction is to be informed by advice provided in consultation with expertise at the venue.

Instruction is required for students on safety procedures and correct techniques (e.g. preventing injury).

Consent

Parent consent is required for all activities conducted off-site.

For activities conducted on-site, parent consent is required for extreme risk activities and strongly recommended for high risk activities.

Supervision		
For activities with students with a medical condition or disability that may impact on safety during the activity, consultation with parents is required prior to allocating supervision to determine the impact of students' disability on safety during the activity.		
The number of adult supervisors required to fulfil emergency and supervision roles must consider the nature of the activity, students' ages, abilities and specialised learning, access and/or health needs.	V	
Before the activity, all adult supervisors:		
 must be familiar with the contents of the CARA record must assess <u>weather conditions</u>, and obtain accurate information on <u>tides</u>, depths, currents and other expected water conditions (if applicable) prior to undertaking the activity, inspecting the intended location in order to identify variable risks, hazards and potential dangers. 		
During the activity, all adult supervisors:

Client students/teachers are advised prior to the excursion to bring sun safety equipment and bottled drinking water.

Client schools are required to bring a first aid kit which meets the needs of that school in relation to the specific requirements of individual students and accompanying adults, as well as the variation to routine approval process of the school.

BUEEC staff will discuss program specific equipment prior to use, outlining correct procedures and safety requirements.

Area in use to be checked by BUEEC staff for snakes prior to activity. All BUEEC staff trained in snake bite management. BUEEC staff to check public toilets, to be used by students on the day, for hazards prior to school arrival.

Hazards and Control Measures

Information on managing common hazards and risks in the school environment can be found at <u>Hazards and risks</u>.

Consider environmental hazards

e.g. *Insects and wildlife* - Instruct students not to feed wildlife and how to respond to approaching wildlife. Establish protocols for the use of insect repellent, outlined in <u>Insect viruses and allergies</u>

Consider facilities and equipment hazards

e.g. *Gravel on playing surface* - Conduct a field check to identify and manage surface hazards. Clear the playing surface from loose items or debris. Do not participate on a surface that is slippery, unduly rough or chopped up.

Consider students

e.g. *Exhaustion, fatigue* - Ensure drink breaks occur regularly. Make water available for individual participants between drink breaks. Conduct <u>warm-up/cool-down</u> activities.

This program takes place outside of a classroom. Students should bring along adequate sun protection, a hat and water bottle. Students will be monitored by BUEEC staff for fatigue and establish rest, food and water stops are timetabled into the excursion.

Students will be explicitly instructed on safe & respectful interactions with the public.

BUEEC staff will assess the appropriateness of weather conditions before and during the activity.

BUEEC staff will not allow students to climb trees, constantly monitor surroundings for slip, trip and fall hazards, and ensure that everyone wears appropriate footwear at all times.

BUEEC staff carry a basic first aid kit suited to area in which the excursion occurs.

The client school will provide class lists and advise BUEEC staff of medical information and individual behaviour/learning considerations prior to the excursion.

Students with open cuts and abrasions are to be removed from the activity and treated immediately. If bleeding cannot be controlled completely, the participant should not be allowed to return to the activity. All clothing, equipment and surfaces contaminated by blood should be treated as potentially infectious.

BUEEC staff will support client teachers in implementing the school's behaviour management strategies and plans as required. The BUEEC Student Code of Conduct will be adhered to throughout the program.

BUEEC staff will discuss safety procedures and expectations at the commencement of the activity with client staff and students.

BUEEC staff will monitor students for safe movement around the activity area and during activities.

Client schools are requested to advise of any students with family law concerns.

BUEEC staff supervision of learning areas to identify when there is a need to:

- * Move students away from persons of concern.
- * Monitor intentions/actions of any person approaching the group.
- * Contact police on 000/112 if a problem situation is encountered.

Planning Considerations

Which students will be involved?

- Consider the number of students, size of student groups and students' capabilities e.g. age, experience, competence, fitness, maturity.
- Consider any individual student needs e.g. personalised learning, support provisions (including behaviour support plans), health management (including health plans and prescribed medication requirements).

Where will the students be?

- Consider the location of the activity e.g. remote/easily accessible, public /private, school/classroom/workshop/other.
- Is the number of students appropriate for the available space?
- If outdoors sunsafe strategies are implemented; weather and environmental conditions are assessed before and during activity (e.g. temperature, storms, water currents, tides); and strategies to reduce the likelihood of viruses, allergies and skin infections caused by insects (e.g. ticks, mosquitoes, spiders) and other animals are applied.
- The site is checked for hazards (e.g. poisonous plants, dangerous animals, uneven terrain, barbed wire,) and necessary controls implemented.
- Activities are appropriately situated in relation to buildings, pedestrians, members of the public, vehicles and other activities e.g. designated areas for activity, spectators and vehicles are established.

What will the students be doing?

- Consider the nature and duration of the activity i.e. need for drinking water, food, rest, appropriate clothing, warm-up and warm-down.
- Instruction in rules and pre-requisite skills is provided.
- Student skills are developed in a progressive and sequential manner.
- First aid and emergency medical treatment provisions are appropriate for the type of activity and location e.g. first aid kit, first aid trained personnel, Ventolin®, Epipen®, and students' personal prescribed medications as required in health plans are available.
- Emergency response strategies are in place e.g. communication plans (e.g. mobile phone, walkie talkie), safety induction, evacuation plans.
- Hair, clothing, footwear and jewellery are worn in a manner that is appropriate and safe for the activity.
- Personal items, e.g. drink bottles, towels and mouthquards, will not be shared between students.

What will the students be using?

- Instruction in safety procedures and safe handling of equipment is provided.
- Equipment is suitable for the activity, properly maintained, appropriately used and complies with the relevant safety standard.
- Relevant department procedures and guidelines are adhered to for the use of equipment and work processes.

Who will be leading the activity?

- A registered teacher has overall responsibility for the activity.
- Sufficient adult supervision is in place to manage the activity safely (including in emergency situations).
- The activity leader has the competence (knowledge and skills) to plan, induct, instruct and manage the activity safely for students and others.
- There are sufficient adults present with current First Aid qualifications (including CPR) or ready access to qualified first aid personnel.
- Blue Card requirements are adhered to for leaders/volunteers.
- I have incorporated the above factors when planning my risk management strategies for this activity.
- Additional activity-specific requirements for students with specialised learning needs are provided in the Other Details box below.

Curriculum Activity Risk Assessment

Individual student needs e.g. personalised learning, support provisions (including behaviour support plans), health management (including health plans and prescribed medication requirements) are required to be identified by the client teacher. Any subsequent program modifications will be guided by the client teacher or relevant client school staff.

Students will undertake 2/3 activities during the program that take place on the beach/lagoon and in the surrounding parkland. They are instructed prior to the commencement of this activity that at no point are they permitted to enter the water. A BUEEC teacher will supervise these activities and the associated restrictions at all times.
